YMCA facilities range from single-branch community centers to expansive associations with dozens of branches and hundreds of programs.

### Personal Connection to the YMCA

VolunteerMatters' co-founders have a personal connection to the YMCA, beginning as two brothers who found a sense of belonging through a YMCA martial arts program as children. The Y not only shaped their values but also introduced lifelong mentors, one of whom became the first outside investor in VolunteerMatters.

This "full circle" experience continued when YMCA of the USA (Y-USA) released a Request for Proposal in 2015 to implement a standard volunteer management system. VolunteerMatters was selected, and today, the platform supports over 270,000 YMCA volunteers across 510 locations at 85 associations.

## 3 Complex Needs, Powerful Solutions

---

The YMCA presents a unique challenge: it functions as multiple nonprofits under one roof. Volunteer roles, onboarding processes, and compliance requirements can vary significantly by program type, location, and volunteer tier. To address this, VolunteerMatters developed:

### Customizable Project Frameworks

VolunteerMatters allows different configurations for each program—be it food distribution or swim coaching—within the same organization. This flexibility enables:

- Program-specific onboarding
- Independent credential tracking
- Role-based visibility for staff and volunteers
- Distributed and centralized administrative access

### Scalable Architecture

From small Ys with \$500K budgets to large associations with \$200M+ in revenue, the system supports:

- Hundreds of distributed admins
- Individualized user access by role and program
- Configurable workflows to accommodate high volume

---

YMCA's commitment to child safety and risk mitigation is unparalleled. They have become a national standard bearer, implementing::

- Annual background and reference checks
- Child abuse prevention and mandated reporting training
- Multi-tiered onboarding protocols
- Audit-ready credential tracking systems



## VolunteerMatters Innovations Inspired by the Y

To meet these needs, VolunteerMatters introduced:

- Integrated background and reference checks
- Electronic agreements and waiver signing
- Online learning course integration
- Automated reminders and workflow triggers
- Document upload and approval tracking
- Annual requirement enforcement

This compliance infrastructure helped one major Y increase adherence from 26% to over 90% in two months—while reducing administrative labor.

## 5 Praesidium Accreditation Support

---

YMCA of the USA has recently implemented a requirement for all branches to obtain Praesidium Accreditation, a gold-standard certification that ensures youth-serving organizations have strong policies and practices to prevent sexual abuse. This includes rigorous standards for screening, training, monitoring, and administrative practices.

VolunteerMatters' existing tools have made it significantly easier for YMCA associations to meet these standards on the volunteer management front.

### Key capabilities that support compliance with Praesidium standards include:

- Tracking of required volunteer credentials and trainings
- Automatic enforcement of repeat background checks and child safety courses
- Documented workflows and audit-ready reporting
- Role-based access to manage multi-tiered volunteer requirements

As a result, many YMCAs using VolunteerMatters have found that they are already well-positioned to pass Praesidium audits without needing to change their volunteer processes—demonstrating how a thoughtfully designed system can naturally align with best-in-class safety practices.

Recognizing that many YMCA staff manage volunteer programs as a small part of their role, VolunteerMatters prioritized **elegance and ease of use**:

- Volunteers have self-service portals for onboarding
